University Offers Summer Course in Disability Services

The course **Contemporary Services for Persons with Disabilities (EDPA 5356, 3 credits)** will be offered at the University of Minnesota, June 9-20, 8 am-11:50 am, Monday through Friday. The class examines current policy, research and practices related to education, health and social services that support individuals with special needs and their families across their lifespan. It is on one of the core courses for the Certificate in Disability Policy and Services, a 12-credit interdisciplinary program especially focusing on developmental disabilities, and designed for graduate and undergraduate students, as well as practicing community professionals.

The summer course is a joint effort of the University's Department of Education Policy and Administration, and the Institute on Community Integration.

Once completed, we will be piloting five families to “test” the model and tool.
